To require a guidance clarity statement on certain agency guidance, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Guidance Clarity Act5 of 2021".

6 SEC. 2. GUIDANCE CLARITY STATEMENT REQUIRED.

7 (a) DEFINITIONS.—In this section:

8 (1) AGENCY; RULE.—The terms "agency" and
9 "rule" have the meanings given those terms in sec-

6 on any guidance issued by that agency on and after the
7 date of enactment of this Act.

8 (c) GUIDANCE CLARITY STATEMENT.—A guidance
9 clarity statement required under subsection (b) shall—

10 (1) be displayed prominently on the first page11 of the document; and

(2) include the following: "The contents of this
document do not have the force and effect of law
and are not meant to bind the public in any way.
This document is intended only to provide clarity to
the public regarding existing requirements under the
law or agency policies.".
